### TUITION POLICY

By signing the enclosed application, you are agreeing to the terms and conditions of this tuition policy.

Tuition is based on services rendered during those days specified on the annual school calendar.

Two methods of tuition payment are offered: an annual payment with a percentage discount or a monthly payment. **Annual tuition must be paid by July 15, 2010 or ten days after the date of billing. Monthly tuition is based on either of the following payment schedules:**

Part-time Preschool (3-4 and 4-5)  
Fulltime Infant - Preschool

9 monthly installments from September 1 through May 1  
12 monthly installments from July 1 through June 1

**Monthly payments are due on the first of the month and considered past due after the 15th of the month.** Accounts not paid in full by the 15th of the month will be assessed a \$25 late fee. If the 15th falls on a weekend or holiday, the next business day will be the last day to pay accounts in full.

Once an account becomes past due, the entire balance must be paid and the account brought current in order for a child's admission to continue.

There will be a fee of \$25 for all checks returned NSF and all returned EFT payments.

**STUDENT WITHDRAWALS** Parents planning on withdrawing their children should do so in writing (including e-mail) prior to the 15th of the month. There will be no penalty, although the full month's tuition will still be due. Those who withdraw after the 15th of the month will be assessed a withdrawal penalty of \$250 per student.
